\$50 License Fee

All applicants must provide proper documentation of the following:

1. The most recent health inspection report and County Health Department permits for the Food Preparation Establishment.
2. A letter of agreement from the Food Preparation Establishment agreeing to comply with all applicable laws and regulations.
3. The most recent health inspection report and County Health Department permits for the Food Truck.
4. Plans and specifications for the Food Truck, including the layout, photographs, mechanical schematics, equipment types, manufacturers, locations, dimensions, weight of vehicle per wheel, power source, installation specifications, and information on any custom fabricated equipment.
5. Copies of all licenses or permits required by the State of Illinois Department of Health and Department of Transportation for the operation of the Food Truck.
6. Documentation of written consent from all property owners stating the food truck is allowed to operate on the property.
7. Signed Release and Waiver of Liabilities (attached)
8. Proof of maintaining public liability, food products liability, and property damage insurance as will protect vendor, property owners, and the Village from all claims for damage to property or bodily injury, including death, which may arise from the operations under the permit or in connection therewith in accordance with Article 7, Chapter 11. 11-703(8)
9. Driver's license for the vehicle operator, and Food Service Sanitation Manager Certification for the vehicle food service operator.

SECTION 5: ACKNOWLEDGMENT AND SIGNATURE

By submitting this Application, the applicant hereby consents to any inspections required by the Village and agrees to abide by all State and local laws and regulations for operating the Food Truck. Applicant further acknowledges that he or she will abide by Chapter 11, Article 7: Food Vehicles of the Municipal Code of the Village of Bolingbrook and recognizes that failure to abide by said laws and regulations can result in the suspension or revocation of the Food Truck License.
