
**NOTICE OF HEARING**

The public hearing will be held to receive evidence and adjudicate the disability application of the above applicant. The applicant is entitled to be represented by legal counsel, to present any evidence and to respond to any evidence before the Board. Pursuant to Governor Pritzker’s Executive Order No. 2020-07 (COVID-19 Executive Order No. 5), Governor Pritzker has suspended certain rules of the Open Meetings Act – specifically the Executive Order permits remote public meetings.
